

OT & SLP Career Opportunities FAQ



What type of services do you provide and in what locations?

OT/SLP/PT in St. Thomas & St. Croix, U.S. Virgin Islands.

Primarily in-clinic services, with some services provided in local schools, daycares, and homes. We like to be able to offer school/home options when schedules/locations work for the therapists, but this is not a guarantee for families and not mandatory for staff.

What are your clinic hours?

Our clinic is typically open 8:30 to 6 M-F and Saturdays 9-3. Therapists set their own schedules, so working hours vary by therapist. We often coordinate back-to-back services for families; communication with colleagues is key.

What are the primary diagnoses/conditions you treat?

We serve children with a wide range of diagnoses but have a high incidence of young children with autism. We provide early intervention services for 0-3, school-based therapy in an ABA-based school for children with autism, and life skills support for a transition program for young adults with autism and developmental disabilities. We see adults on a case-by-case basis depending on the experience and availability of our therapists.

What are the licensing requirements in the Virgin Islands?

- A valid OT/SLP license in any of the 50 U.S. states
- ASHA certification for SLPs, NBCOT for OTs

Do you provide evaluation and treatment materials?

Yes, we have a fully stocked clinic with all necessary treatment materials.

Our therapists are responsible for having their own computer or tablet for documentation.

What documentation/scheduling system do you use?

We use Practice Perfect for our calendars, client files, daily notes, and billing. The desktop version can be downloaded onto a laptop/PC, and the more limited browser-based version can be used on-the-go (or for Mac users). The system can be utilized anywhere with internet access. We require that evaluation reports be completed within 2 weeks, and daily treatment notes completed within 24 hours.

What is the salary range?

Because we value flexibility & balance, we have various part-time to full-time options with customized benefit packages, depending on each therapist's idea of work/life balance; talk with our Sunshine Coordinator for ranges based on your preference and experience. Our therapists schedule their own appointments and set their own working hours. There are opportunities for professional growth and increased income potential with additional "extra credit" tasks.

What benefits do you offer?

Besides the incredible benefit of living in the Caribbean!? 😊 Flexible scheduling and a hard-working support team are our favorite benefits! We also offer health insurance, continuing education, paid time off, and opportunities to earn financial bonuses.

Is there any relocation assistance?

We offer a \$1k relocation stipend contingent upon a 2-year-commitment. Additional "assistance" includes local knowledge for finding the best place to live, discounted car rental upon arrival, support for finding local resources, and a warm welcome to the island culture!
